**RESOLUTION No. 6
OF THE RECTOR OF THE UNIVERSITY OF WARSAW**

of 13 July 2026

**on the amount of fees for accommodation in the student halls of residence at
the University of Warsaw in the 2026/2027 academic year**

Pursuant to § 19, section 1 of the Rules and Regulations of the Student Halls of Residence at the University of Warsaw (consolidated text: UW Monitor of 2026, item 70), it is hereby ordered as follows:

§ 1

1. The amount of the monthly fees for a place at the student halls of residence at the University of Warsaw in the 2026/2027 academic year for students, doctoral students and postgraduate students of the University of Warsaw is set out in the appendix to the resolution.

2. In the case of students and doctoral students of entities with which the University of Warsaw has concluded an agreement within the meaning of Art. 43, section 1, point 30, letter c of the Act on the goods and services tax dated 11 March 2004 (Journal of Laws of 2025, item 775, as amended), PLN 150 shall be added to the fee specified in the appendix.

3. In the case of persons other than those referred to in sections 1 and 2, PLN 150 and 8% VAT shall be added to the fee specified in the appendix.

4. The fee for a child of a student or doctoral student under the age of 5 shall be charged at 50% of the fee specified in the appendix to the resolution.

5. Where one person occupies a double room, the fee shall be 1.25 times the fee for a single room referred to in sec. 1. The conversion of a double room into a single room shall be permitted only where a sufficient number of places is available.

§ 2

1. The amount of the reservation fee for accommodation in the student halls of residence at the University of Warsaw for students, doctoral students and postgraduate students at the University of Warsaw and their children, students and doctoral students of entities with which the University of Warsaw has concluded an agreement within the meaning of Art. 43, section 1, point 30, letter c of the Act on the goods and services tax dated 11 March 2004, as well as beneficiaries of scholarships granted by the Polish National Agency for Academic Exchange [pol.NAWA], shall be equal to the amount specified in the appendix to the resolution.

2. The reservation fee connected with accommodation in student halls of residence for persons other than those referred to in section 1 is double the amount indicated in the appendix to the resolution.

§ 3

1. Upon a justified and documented application by a person residing in a student hall of residence, the Head of the Student Welfare and Support Office may exempt that person, in whole or in part, from the fees for accommodation in the student hall of residence or allow the fees to be paid in instalments.

2. The grounds for exemption from the fee or for payment in instalments may include, in particular:

- 1) the status of a carer of a person with a disability residing in a student hall of residence;
- 2) the student's or doctoral student's difficult financial situation;
- 3) the student's or doctoral student's difficult personal circumstances;

3. The applicant shall indicate whether they are applying for a full or partial exemption from the fees, or for payment in instalments, the period for which the exemption is sought, and the student hall of residence in which they reside. Where the application is for a partial exemption from the fees, the applicant shall also specify the amount of the reduction sought.

§ 4

The resolution enters into force on the day it is signed.
